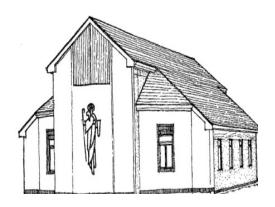

Memorials

When the congregation receives contributions in memory of a loved one over \$100, the monies are deposited in the Memorial Fund in that person's name until an appropriate memorial can be purchased or an item is needed. There is a five (5) year grace period after which monies not used will be transferred into the Discretionary Fund of the Savings Account. Monies left in memory of a loved one totaling less than \$100 will automatically be transferred to the General Fund. Families

will be encouraged to consider placing the memorial money in the Discretionary Fund of the Savings Account.

Envelope Data

Offering and Special Giving Envelopes are sent to those who request them. Once they are returned, Deacons mark the amount and give the money to the Church Treasurer to deposit and the envelopes are given to the Financial Secretary to record the amounts based on the envelope number in order to generate a giving statement for contributors at tax time. Colleen Shields oversees the data entry weekly and generating weekly, monthly, and quarterly reports.

VALOR Program

VALOR (Veterans Assistant Living Out Reach) provides shelter, food, supplies, and access to healthcare for homeless veterans. Members of Good Shepherd UCC volunteer normally the last Sunday of the month to cook an average of 16 meals per month and deliver them to Paul's House in Jonas, PA.

CACPAC Program

CACPAC (Christian Action Council of Palmerton Area Churches) was founded as early as 1971 by Sacred Heart Catholic Church, First United Church of Christ, St. John's United Church of Christ, and St. John's Episcopal Church. Food and monetary donations help stock the shelves of the CACPAC Food Pantry where canned food and other nonperishables are distributed to community residents who have a temporary need for food.

Northern Lehigh Food Bank Program

The Northern Lehigh Food Bank began in 1987 under the leadership of Rev. David Johnson and the directorship of Ruthann Mantz and has continued serving the needs of those in the Northern Lehigh School District struggling to put food on the table for themselves and their families ever since. In addition to the weekly distribution of food, the foodbank spearheads holiday meal baskets with Good Shepherd UCC collecting cans of corn which included in 2023 the following 168 cans of corn for Easter, 212 cans of corn for Thanksgiving, and 254 cans of corn for Christmas.

'Soup'er Bowl Program

The Youth of Good Shepherd UCC has spearheaded the collection of soup and crackers since prior to 1998. These items are collected during the month of January leading up to the Super Bowl with a monetary request on Super Bowl Sunday. The items collected are donated to the Northern Lehigh Food Bank and the cash gifts are given to CACPAC to help in the distribution of food to those in need. The Super Bowl was held on February 12, 2023, and the following was collected: 68 cans of soup and 17 boxes of crackers.

Family Promise Program

Since 2022, Good Shepherd UCC and Heidelberg Union Church have worked together to house homeless families at the Heidelberg facilities with volunteers from both congregations providing meals and overnight coverage for a span of one week increments for up to four (4) families that have no homes. In 2023, our volunteers hosted from February 26 to March 4, and October 15 to 22.

Backpack Buddies Program

Since 2018, the Northern Lehigh School District designed a program with the help of local congregations to provide food for young people who depend on the school district to provide subsidized meals during the school week with backpacks full of canned fruit, vegetables, canned chicken, canned tuna, boxes of macaroni & cheese, canned ravioli, and other nonperishable items high in nutritional value. The students pick up their backpacks filled with items each Friday to provide food through the weekend, then bring the backpacks back on Monday to be refilled.

Mitten Tree Program

Each winter season, a Mitten Tree is placed in the Narthex for people to place hats, gloves, mittens, scarves, etc. for those in need of such items during the winter. The items are divided between men, women, and children with the men's items going to Allentown Rescue Mission and the women and children's items going to the Sixth Street Shelter. In 2023, the following was collected: 10 pairs of women's gloves, 9 hats, 2 scarves, 1 pair of earmuffs, and 1 hat-scarf-hat set; 9 pairs of children's gloves/mittens, 5 hats, and 1 pair of earmuffs; and 5 pairs of men's gloves, and 4 hats.

Secret Santa Program

Northern Lehigh Food Bank began the Secret Santa Program in 2008 and is currently sponsored by Friedens UCC. Good Shepherd UCC adopted five (5) children: a girl aged 6, a girl aged 10, a boy aged 6, a boy aged 16, and a boy aged 17. Three (3) gifts with a minimum of \$25 were purchased for each child with the donor wrapping the gifts and the coordinator bagging the gifts for pickup at Friedens UCC.

Endowment Program

For many years, members of First UCC, Palmerton provided money to the Endowment Fund to help missions beyond the church walls. The dividend of his money is portioned quarterly with 80% of the dividends designated to ministries apart from Good Shepherd UCC while the remaining 20% is returned to the fund's principal. In 2023 the following received grants:

Penn Northeast Conference

The focus of the fall meeting of the Penn Northeast Conference of the United Church of Christ was to explain the progress in combining the four conferences in Pennsylvania into one Keystone Conference. The conference ministers of Penn Northeast, Penn Southeast, Penn Central and Penn West spoke of the needs and different responsibilities of each area.

The obvious need of all four conferences was to save money, and cutting from four conference ministers to one, and some overlapping staff, will help. Still, core responsibilities must be met. Search and call for churches and pastors; legal, administrative and financial oversight; conflict resolution; church starts and closings; these are the highest priorities. Close behind are local staff, seniors, youth, disaster relief, pastoral care and congregational futures. Then how much UCC identity is needed? How much ecumenism? How much spiritual revival? How much continuing education do pastors need, and who will provide it? Who will document it? The questions go on and on.

Several people asked the conference minister panel, "Why don't we focus on loving God and neighbor? Make everything else secondary." The answer came from the audience as they continued to push their own pet projects. And, as one who came to Good Shepherd from First, where every three years we were in a search committee or seeking an interim pastor, we would have been lost without conference's guidance.

Finally, the four conferences are looking to resolve all these issues by November 9, 2024. That is when the proposal must be in the hands of the national church in order to be accepted at the next Synod. Any later and there is a two year wait until the next Synod. We don't know how the four conferences will fare with that delay.

Progress on returning borrowed money to the savings account has been made but bills still need to be paid, so money still needed to be moved from savings to checking to pay the bills.

Lastly, it was mentioned that the salary for the Faith Formation Director was kept in the budget even though we don't currently have one.

Meeting was adjourned at 11:25 am.

Congregational Meeting

The Congregational Meeting took place on November 19, 2023, at 10:55 am. The vote meeting was called to order beginning with a prayer. There were 26 members in attendance and 30 names on the list. Carol Krum made a motion to vote, and Joe Conway seconded the motion.

One comment mentioned for the budget was that Matt Shields did not accept a raise for 2024.

There were 24 "yes" votes and 0 "no" votes. 6 votes were initially unaccounted for, however, it was later determined that these were members who had cast their vote the week before at the Budget Hearing, because they knew they would not be at the Congregational Meeting for the actual vote.

The budget passed.

Joe Conway made a motion to adjourn the Congregational Meeting and Eddie Smith seconded the motion. The meeting was adjourned at 11:08 am.
