

2020 ANNUAL PASTORAL MESSAGE

Dear Disciples of Christ here at Good Shepherd ~

This has been an unprecedented year. A year fraught with concern, as well as opportunity. In an article by Josh Laxton, he reminded me of the story of Joseph in Genesis, where his brothers sold him into slavery and years later Joseph responded, "Don't be afraid. Am I in the place of God? You intended to harm me, but God intended it for good to accomplish what is now being done, the saving of many lives." In this, Joseph offers a new perspective.

What new perspectives has the year 2020 to offer us? A year that saw the beginning of a pandemic, racial inequalities, violent demonstrations, political chaos, and division separating family and friends from one another. God calls us from the limitations of this world to seek the Kingdom that is God's realm of grace and mercy.

2020 has been a year of loss \sim loss of jobs, businesses, opportunities, experiences such as sporting events, movies, concerts, etc., also experiences for youth to attend school, proms, sporting events, to create and maintain friendships, and most of all the loss of loved ones who have died because of COVID 19. As pastor, I have been called on to offer hope and a sense of continuity in a sea of change. Many individuals feel anger, resentment, and depression. We are called to deal with these feelings in a healthy and holistic way that allows us to grieve and yet know that through God's promises all is not lost.

2020 has also been a year of social distancing ~ having drummed into us the three W's: wash your hands, wear your mask, and watch your distance. Our hygienic behavior due to the three W's has reduced the occurrence of colds and the common flu. It has also increased our appreciation for community, a simple hug, shaking hands, a personal touch. Our community becomes more aware of being "present" in good times and bad.

2020 has been a year of shutdowns ~ workplaces closed and schools turning to online learning along with areas we take for granted like restaurants, movies, coffee shops, gyms, parks, and travel all of which have been closed or limited to access. However, with remote learning and working, we have more time with family and able to reclaim activities such as writing letters, reading books, walking, or running, holding game nights, talking with family members, and getting home projects done. We have been given a chance to learn again what is most important and that is the relationships in our lives and honoring the love that binds us all together.

I believe we here at Good Shepherd have grown in spite of the pandemic. We have been affirmed and reaffirmed in the ministry and mission we are called to in ways we never thought possible. We have allowed ourselves to change letting go of things that were holding us back as well as welcoming new ways to work in the service of Jesus Christ.

The pages that follow will show how we as a congregation were able to demonstrate the love of God in the midst of a pandemic.

- Due to COVID:

 - o The annual Easter Egg Hunt and Easter Egg Coloring was cancelled
 - o Midweek Lenten Gatherings were cancelled
 - Adult Faith Formation Class taught by Mary Lacy will be postponed until there are no health risks for those vulnerable to the virus
- Confirmation Process to include approximately 15 sessions during varied times of the week, including trips that would enhance the lesson, i.e., visit an actual stable to discuss the lesson on the birth of Christ. The confirmands covenant to complete all sessions according to their own timeline and availability, sessions would be offered approximately twice a year. Once all the sessions are completed, then the confirmand could be confirmed, no matter how many years it takes to complete, if all the sessions have been completed. Envelope Data

<u>Chancel Choir</u>: led by our Choir Director, Beth Kutzner, began rehearsing August 18 with 5 members and by the end of the year had 12 members. The choir rehearses Tuesday evenings at 7 pm. The rehearsals are held in the sanctuary and members practice social distancing, which includes keeping six (6) feet apart and masks are worn. The anthems are recorded for Sunday morning worship, and we will continue in this format until it is determined to safely sing during church services. Members of the Chancel Choir met for a small Christmas Gift Exchange and Appreciation Gathering on Tuesday, December 22.

<u>Hanging of the Greens</u>: took place Saturday morning, November 28 with 18 people gathering to decorate the sanctuary for the Christmas season. The service was quite different from past years due to the CDC restrictions.
