

I had approximately 22 funerals in 2022 and took in 29 new members as well (including 11 confirmands). Baptisms are on the rise as are weddings. Our ministry is alive and well.

This past year we began a mission project working with Heidelberg Union for homeless families in the Lehigh Valley. There are many volunteers to help with this mission which includes cooking a meal for approximately four families and staying overnight in case of an emergency. Thank you to Ann Hayes for heading up our team and coordinating with the people at Heidelberg.

This mission joins our work with VALOR and feeding the homeless vets. This mission is still going strong thanks to the efforts of Deb Craig who spearheads this project.

Another mission we've been involved with over the years and is still going strong is the Northern Lehigh Food Bank. Collection of corn for holiday meals is greatly appreciated along with the volunteers that assist with stocking shelves and helping distribute foods to those who are in need.

There are more opportunities for missions waiting for us in 2023. I hope all the disciples at Good Shepherd consider ways they can be a part of what is happening at Good Shepherd UCC and growing in faith knowing we are part of something bigger than we are alone.

- Food donations help stock the shelves of the CACPAC Food Pantry where can food and other nonperishables are distributed to community residents who have a temporary need for food.

NORTHERN LEHIGH FOOD BANK PROGRAM

- The Northern Lehigh Food Bank began in 1987 under the leadership of Rev. David Johnson and the directorship of Ruthann Mantz and has continued serving the needs of those in the Northern Lehigh School District struggling to put food on the table for themselves and their families ever since

FAMILY PROMISE PROGRAM

OTHER MISSIONS

REPORT OF THE PENN NORTHEAST CONFERENCE SPRING MEETING

The theme of the 2022 Spring Conference Meeting was that the Golden Rule – "Do unto others as you would have them do unto you." – is a common teaching in every major religion. We were not able to make the Friday evening teaching by Valarie Kaur, a Sikh by religious training and an interfaith leader. We were told that her teaching was about how our desire to do good to others can often backfire against us. When we try to treat others as we'd like to be treated, too often we do to another our preferences and not theirs, and those two things can be very different, sometimes resulting in conflict. Instead, we should make a diligent effort to learn the other's true desires.

A Jewish rabbi taught that we cannot rely on God to direct our charitable work; rather we must put our own moral judgment and work to do good into action as we reflect God's guidance. A Baha'i leader taught that his religion believes that all monotheistic Gods are one, and that all of their prophets have standing. Unfortunately, an Islam leader could not attend to teach. Still, the universality of seeking to "care for each other" was present in each major religion.

The other thing that caught our attention was similar to our last report from the Conference Meeting, but now with more detail. Three years ago, Conference had to borrow \$25,000.00 to balance its budget; since covid, none at all. As the faithful in Conference rose to meet the needs, it was pointed out six months ago that that was true for us as well. Ann and I hope that remains true today.

REPORT OF THE PENN NORTHEAST CONFERENCE FALL MEETING

The fall meeting of the Penn Northeast Conference of the United Church Christ dealt with new ways the denomination is reaching out to the "Nones" and the "Dones." The nones are those with no current religious practice; this may be because they have never had exposure to religions, or they have walked away from what they believe is brainwashing. The dones have been active in church life, but they no longer want to be a part of that. So, they were asked what their favorite diversion is; what do you like to do in your non-working times. The most common answer: Show me something that deals with good and evil, but without judgment. Harry Potter, Star Wars, Star Trek, Lord of The Rings. The list could go anywhere. (I probably shouldn't admit it, but one of my diversions is Blue Oyster Cult music.)

The nones and dones don't like God – he's too authoritative – but they like Jesus. Jesus is always telling stories, so you can approach him from where you live. Jesus spoke to his disciples, a rather disparate group, he spoke to groups of thousands, but he could also comfort and advise the woman at the well. He listened to others and gave advice, but he didn't say, "This is the only way!" The church should be doing the same. They should show people the process, not the project, because they must be open to those people's stories. And, by the way, that is what we seek to be doing with our "Open and Affirming" program.

From the business part of the meeting, I have pointed out how well conference was financially supported during the trying times of Covid. Now, as the pandemic fades into the background, it would appear that many of us have gone back to our old ways of helping out too. Consider that as you decide your support for Good Shepherd.
